4ii. Survey Faculty regarding Posthumous Degrees	<p>Right before winter break, a survey was given to the Faculty in regards to posthumous awards. A general consensus was that giving a posthumous award is the right thing to do as a humanistic university.</p> <p>The questions comes up with do we give the award in the discipline of the students enrollment or should it be an honorary doctorate of humane letters? How far into the degree should they be in order to qualify for the doctorate? The mean was 62, which would be two thirds of the degree. After doing research at what other colleges have done across the nation, it is predominately that they are through their candidacy phase.</p> <p>Language will be put together and sent to Dr. Guidry.</p>
