2025 APPLICATION PROCESS AND CHECKLIST

This checklist is provided to assist you in submitting all the required materials. The following items must be submitted on or before May 1, 2025. Qualified candidates will be invited to interview.

 Online Application & Application Fee The OptomCAS application must be electronically submitted on or before May 1, 2025. OptomCAS charges \$187 USD for the first program you apply to and \$80 USD for each additional program.
 Foreign Coursework Evaluation
Official transcripts for all coursework completed outside the United States or Canada must be submitted to World Education Services or Josef Silney & Associates for a <u>U.S.course-by-course</u> evaluation. The evaluation service should then send/release the official evaluation to WesternU or OptomCAS.
 Official Transcripts for U.S. Coursework
Official transcripts for any courses completed at U.S. or Canadian institution must be submitted through OptomCAS.
 Official TOEFL or E3PT Scores
All applicants whose native language is not English must submit official ETS TOEFL or English3 (E3PT) score results.
 Standarized Test Requirement
The Optometry Admissions Test (OAT) is the perferred required Standarized Test. The OAT must be completed on or before May 1, 2025. DAT, PCAT, and MCAT can be considered on a case-by-case basis by the committee.
 Letters of Recommendations
We require two letters of recommendation. It is suggested that one letter be from an optometrist/clinical supervisor, and one from a faculty member, pre-health advisor, or employee who is familiar with the applicant's work. The request for a letter of recommendation will be sent via OptomCAS.
 Minimum of 90 semester or 135 quarter units of undergraduate coursework
All units must be at a regionally accredidated instituation and must be completed by June 30th prior to matriculation.
 Successfull Completion of All Required Prerequistics
List of required courses are on the WesternU OD Admissions Webpage. All prerequistics must be completed at a regionally accredidated instituation, must be completed with a grade of "C" or better (a grade of "C-" or lower is not acceptable), one course cannot be used to satisfy more than one prerequisite, and all coursework must be completed by June 30th prior to matriculation.
 Proof of Legal U.S. Residency - if required
International applicants, or any other applicants who are not U.S. citizens and who are living in

the U.S., must provide proof of legal U.S. residency prior to matriculation.
